1. The Kingdom of Bhutan has received a loan from Asian Development Bank (ADB) towards the cost of Urban Infrastructure Development Project. Part of this loan will be used for payments under the contracts for **Babessa LAP**. Bidding is open to **all eligible ADB member countries**. However, a successful bidder is required to register with the Construction Development Board (CDB) of Bhutan before award of contract.
2. **Thimphu City Corporation**, Ministry of Works and Human Settlement, RGoB (the "Employer") invites sealed bids from eligible bidders for the **Construction of Road & Drainage, Water supply, Sewerage and Cable Duct** ("the Work").
3. Only eligible bidders with following qualifications should participate in this bidding:
 - **Key experience requirement : 5 years**
 - **Key financial requirement: Minimum Average Annual Construction Turnover (AACT) of Nu 227 million in the last three years.**
 - **Key equipment requirement : Tipper (5-8 cum capacity); Truck mounted Concrete Mixer; Hydraulic Excavator (PC 200); Back hoe loader; Concrete Mixer (7/5 Cft); Concrete Vibrator; Water pump AVI type; Plate Compactor; Vibratory Roller (8 ton and above operating weight); Steel wheeled roller (8 ton and above operating weight); Water tanker; Power brooms with tractor or equivalent equipment; Asphalt plant; Asphalt paver; HDPE Pipe Jointing Equipment; Total Station with stand targets etc**
 - **Key personnel for project based requirement: Project Manager, Road Engineer, Water supply & Sewerage Engineer, Site Supervisors.**

The details of above requirements are specified in the Bidding Documents.

4. The Procurement will be done through International Competitive Bidding (ICB) in accordance with ADB's Single-Stage: One –Envelope Bidding Procedure.

- b) request for delivery of Bidding Document for " **TCC/RC&WTR/003**", by sending a written application to the Project Manager at the address indicated above. The application must include a Post Fee in the form of a Bank Draft in favor of **Thimphu City Corporation, Ministry of Works and Human Settlement** for the amount of **Nu 5200** (local delivery) or **USD 220** (deliveries to European Countries) or **USD 120** (deliveries to South Asian Countries). The documents will be sent by courier. No liability will be accepted for loss or late delivery.
8. A **Pre-Bid Meeting** will be held on 14th **April 2011** from **14:00** hrs at the **Conference Hall of Ministry of Works & Human Settlement**.
9. The bids should be delivered
- a) To the **Office of the Project Manager, Project Implementation Unit, Thimphu City Corporation, Office No. 12, NPPF Building (Below IMTRAT), Thimphu, Bhutan.**
- b) on or before **14:00** hours on **28th April 2011**;
together with a Bid Security of **Nu.4.6 million** or **USD 104,500/-** in the form of an unconditional bank guarantee or an irrevocable letter of credit; or a cashier's or certified check; payable to **Thimphu City Corporation**
