Terms & Conditions:

- 1. The sealed cover quotation should reach office of the Procurement Section, Directorate Services, and Ministry of Works & Human Settlement Thimphu on or before 15th January, 2019 at 11.00AM.
- 2. The bidder should furnish interest free bid security of Nu.10, 000.00 (Nu. Ten Thousand) only in lump sum. Bid security of the winning bidder shall be converted as Performance Security. The bid security must be drawn favoring Chief Finance Officer, Accounts Division of the Directorate Services in the form of demand draft or cash warrant. The validity of the Bid security shall be valid for a minimum period of Six months. However, those bidders (s) who have submitted such instrument earlier will not be required to resubmit again provided the amount required is same and the validity is not expired.
- 3. The bidder (s) shall enclose copy of the valid trade license along with its bid.
- 4. The bidder shall submit its offer only for the full fare and not for excursion. Therefore, any bid offering excursion shall be rejected.
- 5. The travel/ticketing agent must ensure to submit its offer only for the **confirmed seat** and conditional offer such as wait list or offering alternative route, air fares are subject to increase or change of air line at the time of travel shall not be acceptable and rejected.
- 6. Payment shall be made only after availing the travel trip.
- 7. Travel/Ticketing agents must indicate complete details of the airline and flight number etc
- 8. The offer received after the deadline of submission shall be rejected as received late.
- 9. The travel agents (s) are required to quote only for the sectors mentioned above.
- 10.In case of lump sum round trip offer, the breakup of rate for each sector must be indicated.

- 11. The Bidders should always provide offer for the most direct and shortest route.
- 12. The Bids will be rejected or bidders shall be barred from participating in the subsequent bidding process if they are found to have involved in any form of corrupt practices or in collusion with.
- 13. The bid security of the bidder failing to provide services after the award shall be forfeited and services shall be out sourced from other travel/ticketing agent in the market.
