**Brief Terms and Condition**

1. **Price:** The price offered shall be quoted on CIF MoWHS, Central Stores, Phuntsholing Bhutan. All applicable taxes and levies shall be inclusive.
2. VAT and IGST are not applicable.
3. **Consignee:** In-charge Central Stores Phuentsholing Bhutan.
4. **TDS:** If applicable as per RGoB rule.
5. **Delivery Schedule:** within 30 calendar days from the issue of the supply order.
6. **Late Delivery Penalty:** 0.1% to a maximum of 10% shall be levied on the total order value.
7. **Mode of payment:** after supply completion and all bank transport charges as per actual shall be on the supplier.
